Annual Maintenance Contract

This Preventive Service made at Kollam on the Day between M/s Thottathil Agencies having its Registered Office at WII/ 18 /19,2nd Floor ,Bishop Jerome Nagar, Kollam hereinafter referred to as "THE AGENCY" (which expression shall include its successors and assigns) of the FIRST PART SREE BUDDHA COLLEGE OF ENGINEERING COLLEGEE, PATTOOR and hereinafter referred to as "THE OWNER (which expression shall include its /their successors, heirs, legal representatives, executors and permitted assigns) of the SECOND PART.

The type of contract is Annual Preventive Service and it entitles the following benefits.

1. The Agency shall provide preventive services (4 routine services) for Water Cooler / Air -Conditioner / Deep Freezer / Cold Room supply of all genuine spare parts, attending to all breakdown calls within a small lead time (Schedule of expected down time for various jobs shown against respective section) guaranteeing smooth performance of the machine and advising the customer on technical aspects. The time frame mentioned depends on the array of factors, market forces etc. and this should not be held against the agency in case of default due to reason beyond the control of the Agency.

- 2. The preventive services include filter cleaning, derusting, fan motor lubrication, checking the various subsystems, cooling and condensor coils cleaning, and improving the cooling efficiency of the machine. The electrical spares will also be checked to avoid any compressor burn outs. In the event of finding the coils totally blocked due to dust or dirt, the Agency shall transport the same to their service Centre at their own risk and clean the machine with water.
- 3. The Agency shall supply all spare parts free of cost including compressor.
- 4.In the event of compressor failure the Agency shall replace the same with equivalent repaired compressor obtainable from the original equipment manufacturer or their agents in India upon
- surrendering the defective compressor. 5.Fan motor if failed shall be repaired by the Agency locally and if found beyond economical repair, the Agency shall replace it with a brand new equivalent fan motor. Fan blade and blower if found defective
- shall be replaced free of cost (1 Week). 6.All electrical spares such as capacitors, relays, thermostats, and selector switches shall be replaced immediately upon notice of breakdown due to such failed part(24hrs)

7.Gas leak if any shall be rectified, after necessary leak rectification (3-4 days for Room Air-Conditioners,7 days for Split Air-Conditioners &Water Coolers, 10 days for Deep Freezers and Cold Rooms)

EXCLUSIONS

The following works are excluded from this contract for which the Agency shall charge for the cost of such repairs.

- All masonry, carpentry, electrical, reinstallation and other beautification works shall charged extra.
- Any works not in the scope of this contract.
- c. The agency shall take care of the machine against breakdown, but not against theft, fire, or corrosion, fire arising out of electrical short circuits leading to property losses will not be compensated foe under this contract.
- Periodic patch works ,corroded parts changing, sheet metal fabrication and painting.
- e. The Agency shall not be liable for noncompliance of this contract either in whole or In part of any delay in execution thereof in consequence of any strike, lockouts, fire riots war, insurrection

SPECIAL NOTE

- In the event of major repairs necessitating removal of the machine to our service centre, the owner shall bear the transportation cost.
- Every effort shall be made by the Agency to render prompt service, but you shall not hold the Agency liable for loss, direct or indirect, or incidental arising out of the delay in rendering prompt service due to any reason whatsoever.
- Force Majeure clause shall apply.
- 4. The contract can be terminated by the owner by giving 15 days notice in writing, if the service offered is not up to your expectation. Any unpleasant behavior of our staff is noticed you are requested to bring to our immediate attention.
- Covenants by the owner: the owner shall throughout the said terms.
- Punctually pay all amounts of AMC payable hereunder.
- 7. To permit the Agency's authorized technical representatives to enter and inspect at all reasonable times in which the equipment is for the time being placed or kept, for the purpose of routine service, inspection or examine the condition of the equipment.
- 8. The technician while taking possession of the machine or any part should produce the service centre receipt note or service report duly notifying the date of removal and the particulars of the machine such as Machine Sl.No. ,Compressor Sl.No.

In case the contract is terminated by the owner due to any reason whatsoever, the Agency shall pay the amount advanced after adjusting the prorate charges for the number of months the contract was in force. The damages to any machine in this contract shall also be assessed at the time of their termination which
